Guest Speakers: Future PAC came to speak with our organization about who they are and what they are focused on this election cycle.

DeFazio Report:

State Committee Reports:

Budget - Tai Pruce-Zimmerman: There hasn't been any recent update since the passing of the budget.

Platform - Gerry Rempel: Got through the Platform Committee in one piece. We are hoping to have a resolution passed by Our Children's Trust resolution. There is another resolution regarding Drones that is still being worked on

State Fair - John Booker: With the state fair being August 30th, there is housing that can be provided in Marion County. Rules - Chris Wig: Chris wig has been appointed to chair the state rules committee. There are 2 ways that an amendment can be made to the DPO bylaws. It can be brought through the DPO Rules committee, or that 20 delegates can sign support. The point of the resolution is to re-word which genders can apply as Delegates to the State Committee and County Parties will be male and female and non-binary fairly. The DNC is having a similar conversation right now, and our DPO chair is having a parallel conversation with the County Clerk's that will change the way that PCP's are elected. So there are 3 conversations happening in the same vein. The purpose of this is to have people who do not identify as a gender declare themselves as one. The hope is to have this resolved before every Congressional District has a reorganization meeting. There was talk about "Unwritten" policies. That there was a thought that there were rules that were being enforced without information. Most of the concerns were about how the DPO engages in Primary elections and the idea of supremacy of incumbents.
